Comments on Beaver Valley Probus Club Financial Statements for Year Ending January 31, 2022

- 1 In Fiscal 2021, the Management Committee has endeavored to provide our membership with interesting monthly meeetings and some activities while following all Covid-19 government regulations.
- 2 In May of 2021, a review of the Year ending January 31, 2021 was completed and the letter from Carolyn Leonetti is enclosed. No issues were found.

3 Profit and Loss Statement:

Assuming that our activities and meetings would be restricted during 2021, we reduced our annual fees by 50% to \$15 per person which is reflected in the significantly lower Membership Income in Fiscal 2021.

Based on the recommendations of our speaker chairs, the management committee agreed to increase our per speaker honorarium. Thus our speaker costs increased significantly.

New Member Badges expenses were zero in 2020 because the invoice was paid in January 2020 which was Fiscal 2019.

Probus Canada increased the per member charge from \$2.50 to \$3.00 this year as reflected in "Probus Canada Member Charge" increase.

We did not print a new Member Directory this year as the information is readily available on our website. Therefore significant savings are reflected in " Membership Directory Costs".

"Affini Pay Charges" is the fee for using payment software to process credit card payments to us.

4 Balance Sheet:

Prepaid Expenses includes the payment for our website software(Wild Apricot) that was thru the bank in January but invoice is for Fiscal 2022 and a deposit paid to happenings Party Rental made in March 2020 still to be used.

Accrued Liabilities includes the final payment to Probus Canada for the membership charges for New Members.

The cheque was sent end of January not yet thru the bank.

Also includes Affini Pay Charges for January membership payments paid thru the bank in February 2022.

Prepaid Membership Fees (\$9085) on the Balance Sheet are the membership fees collected in December and January for Fiscal 2022.
